**Ultra Low Flow Toilet  
Rebate Program**

Through the Pinellas County Utilities Ultra Low Flow Toilet (ULFT) Rebate Program, you can receive **up to \$100** for each high flow toilet you replace with an ultra low flow toilet (ULFT).

### how to qualify

- You must be a Pinellas County Utilities retail or wholesale customer (this includes the cities of Clearwater, Oldsmar, Pinellas Park, Safety Harbor, and Tarpon Springs).
- You must be the owner and/or the managing agent of the property where water service is delivered.
- A licensed plumber **MUST** be used when replacing any toilet in a leased or rented single family, multi-family, or commercial property.
- The ULFT(s) (*any toilet that utilizes 1.6 gallons per flush or less*) must replace a high flow toilet(s) (*any toilet that utilizes 3.5 gallons per flush or more*) and be verified by the Rebate Office.

### how to apply

- Request an application from the Rebate Office at (727) 725-2604.
- Upon verification of your water account information, you will receive an application and the program policy and procedures in the mail. Complete the application and proceed with the purchase and installation of the ULFT(s).
- Submit the completed application and ULFT sales receipt(s) to the Rebate Office:

- The Rebate Office will schedule an on-site installation verification with you to confirm that EACH installed ULFT (*1.6 gallons per flush or less*) under consideration for rebate has replaced a high flow toilet (*3.5 gallons per flush or more*). **Do not dispose of the old toilet(s) prior to verification.** Disposal of the old high flow toilet is the responsibility of the customer.
- After successful completion of verification, you will receive the appropriate rebate(s) of up to \$100 for each toilet replaced.

### what qualifies for rebate



- Tank
- Bowl
- Plumbing parts:
  - flange
  - wax ring
  - water supply line
  - mounting hardware
